INVITATION FOR TENDERS

1. The Government of the United Republic of Tanzania has set aside funds for the operation of the Tunduru District Council during the financial year 2017/2018. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract of the Hydro Geophysical survey, drilling and development, pumping test, Water quality analysis and capping of (4) four productive boreholes of Mhuwesi, Nakapanya, Majimaji and Mchoteka in Tunduru District council.

The Tunduru District Council now invites sealed Tenders from eligible contractors registered or capable of being registered in class six or above for carrying out the Hydro Geophysical survey, drilling and development, pumping test, Water quality analysis and capping of (4) four productive boreholes of Mhuwesi, Nakapanya, Majimaji and Mchoteka in Tunduru District council.

4. Tendering will be conducted through the National Competitive Bidding/tendering as specified in the Public Procurement Regulations, Government Notice No.446 of 2013 and is open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.
5. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the Secretary of the Tender Board P.O Box 275 Tunduru from 8.00 am to 15.30 pm on Mondays to Fridays inclusive except on public holidays.
6. A complete set of Tendering Document(s) in English and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 7 below and upon payment of a non-refundable fee of TZS 100,000.00. Payment

should either be by Cash, Banker's Draft, or Banker's Cheque, payable to District Executive Director, Tunduru.

7. All Tenders must be accompanied by a Tender securing declaration in the format provided in the Tendering documents unless otherwise stated in the Tender Data Sheet.

All Tenders in one original plus two copies, properly filled in, and enclosed in plain envelopes must be delivered to the address Secretary of the Tender Board, P.O Box 275, Tunduru room No. 35 or 36 first floor at or before 2:00 pm on 8th June, 2018. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the Tunduru District Council Conference room (Boma Hall).
9. Late Tenders portion of Tenders, electronic Tenders, Tenders not received, Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
